

Royalty-free license agreement to use the original work or derivative works with the authorization to sublicense under Creative Commons licenses

1. The Author hereby warrants that he/she is the sole creator of the Work which the Author submits to be published in the journal *Konińskie Studia Społeczno-Ekonomiczne (Konin Socio-Economic Studies)*.
2. The submission of the Work mentioned in 1 above is tantamount to entering into royalty-free license agreement to use the original work or derivative works with the authorization to sublicense under Creative Commons licenses with State University of Applied Sciences in Konin, Przyjaźni 1, 62-510 Konin, represented by editor-in-chief of *Konińskie Studia Społeczno-Ekonomiczne (Konin Socio-Economic Studies)*, prof. Jakub Bartoszewski, acting on behalf of the Rector, hereinafter referred to as “the Publisher.”
3. The Author declares that the Work has not been published as of yet and is not considered for publication in any other publishing procedure, which remains in accordance with the Publisher’s policy of publishing in scholarly journals only original material.
4. The Author declares that the Work is entirely original and warrants that it has been created without infringing moral and economic rights of other persons and personal rights of third parties.
5. The Author declares to have submitted the final version of the Work and warrants that it has been prepared with all necessary diligence in regard to content, layout, and language as is customary of this type of publication and in accordance with the manuscript preparation guidelines made available to the Author prior to the process of writing the Work.
6. The author declares that his/her copyright for the Work is not encumbered with any third party rights and that the use of the Work by the Publisher will not infringe any third party rights.
7. The Author grants the Publisher non-exclusive and free of charge license to unlimited use of the Work worldwide over an unspecified period of time in the following areas of exploitation:
 - a) digitalization of the Work to a specific format by means of a technology chosen by the Publisher;
 - b) recording the Work in computer memory (incl. servers);
 - c) production of multiple copies of the Work by use of a given technology including, printing, reprography, magnetic recording, and digital technology;
 - d) marketing authorization, loan, or lease of the original Work or copies thereof;
 - e) public performance, display, video screening, reproduction, broadcasting and re-broadcasting, made available to the public in such a way that members of the public may access the work from a place and at a time individually chosen by them;
 - f) inclusion of the Work into a collective work;
 - g) inclusion of the Work in an electronic form to be offered on an electronic platform or any other introduction of the Work in its electronic form to the Internet, Intranet, Extranet, or any other network;
 - h) dissemination of the electronic version of the Work in the Internet, Intranet, Extranet, or any other network as part of a collective work or independently;
 - i) dissemination of the electronic version of the Work in such a way that members of the public may access the Work from a place and at a time individually chosen by them, particularly over the Internet, Intranet, Extranet, or any other network;
 - j) use of samples of the Work for informational, promotional, or advertising purposes;
 - k) making the Work available according the Attribution 4.0 International (CC BY 4.0) Creative Commons sub-license or any other language version of this license or any later version of the license published by Creative Commons.
8. The Author grants the Publisher permission to send meta data files related to the Work or the Work itself to commercial and non-commercial databases and repositories.
9. The Author grants the Publisher permission to use and dispose of rights to compilations of the Work and these compilations on a free-of-charge basis.
10. Because of the royalty-free provision of services of the Author, as stipulated in the present Agreement, the Author shall not be entitled to any remuneration from the Publisher.
11. The Author grant the Publisher permission to introduce to the Work any necessary corrections and changes indispensable in the publishing process.
12. In the case of third party claims or actions for indemnity against the Publisher owing to any infractions related to any form of infringement of intellectual property rights protection, including copyright infringements, the Author is obliged to take all possible measures necessary to protect against these claims and, when as a result of legal action, the Publisher, or any third party licensed by the Publisher to use the Work, will have to abandon using the Work in its entirety or in part or, following a court ruling in a legal challenge, to pay damages to a third party, whatever the legal basis of liability, the Author is obliged to redress the damage resulting from claims made by third party, including costs and expenditures incurred in

the process.

The Author declares that on the basis of the license granted to the Publisher by the present Agreement, the Publisher shall be authorized to grant third parties further licenses (sublicenses) for the Work and other material, including derivative works or compilations containing or based upon the Work, and provisions of such sublicenses shall be compliant with the Attribution 4.0 International (CC BY 4.0) license format or any other language version of this license or any later version of the license published by Creative Commons.
